Update current status of progress of amendment of AT continuing education regulation K.A.R. 100-69-10.

Summary of Amendment

Amendment removes requirement that ATs participate in at least two categories of annual continuing education (“CE”). This amendment does not change the total number of CE hours still required (20 hours each year).

Temporary Regulation in Effect

K.A.R. 100-69-10 Temporary Regulation effective August 31, 2022. Temporary regulations are effective for 120 days or until permanent regulation replaces.

Permanent Regulation Public Hearing October 26, 2022

K.A.R. 100-69-10 Permanent Regulation presented to Legislative Joint Committee on Rules and Regulation (“JCARR”) on October 18, 2022.
