 - a. **Review Discussion from Last Meeting Comparing Board of Certification for Athletic Trainers (BOC) 2022 Continuing Education Requirements Eliminating Evidence Based Practice (“EBP”) Category and K.A.R. 100-69-10.** Review of email Wiebe sent today. At the last meeting (November 2, 2021) the Council voted to recommend the Board remove section (g) from K.A.R. 100-69-10. Council concerned that no EBP courses will be available since BOC is no longer requiring them at the national level. See chart sent with email regarding categories. Most ATs get CEUs in Category A unless they are in higher education. Fitzhugh still feels eliminating section (g) is best action – as opposed to removing or altering wording re EBP wording – doesn’t want to eliminate categories since some are able to use all 4 to get CEUs. Wiebe suggests Fitzhugh consider attending Board meeting to answer questions and provide background. Wiebe will email all council members following this

meeting to make sure all are okay with this course as Payne and Stevanus are out today). Wiebe gives information on regulation process. Goerl asks about CEU minimums – all hours can be met with Category A (no max) but some max in other categories – do want some minimums.
